Colombian Mines Update on Yarumalito Exploration Drilling

Vancouver, British Columbia, April 9, 2010 (TSX Venture Exchange: CMJ) – Colombian Mines Corporation (“Colombian Mines” or “the Company”) has completed the first three core holes in the Escuela target area at the Yarumalito gold – copper porphyry for a total of 751 meters. All three holes have encountered alteration and mineralization typical of the gold-copper porphyry system mapped and sampled at the surface. The Company expects to have assay results back from the lab for all 3 holes in the next 2 weeks with results out before the end of the month. The following table provides a summary of the drilling to date.

Holes 6 through 8 were angle holes completed from the same drill site at the La Escuela target, which lies at the east end of a west-northwest trending, 1.0 by 0.5 kilometer structural zone characterized by previous drill delineated gold mineralization, historic underground mine workings, and anomalous rock and soil geochemistry. The 2010 Yarumalito drill program is planned for a minimum 1,200 meters of HQ diameter core in four to six angle holes. There are currently two drill rigs on the property that are focused on the gold-copper mineralization at the La Escuela porphyry target, and the Company is permitting additional drill sites. Recent gold porphyry and porphyry related discovery successes in Colombia include the nearby Marmato system, as well as the La Colosa and Angostura deposits.
